Thank you for your extraordinary patience related to being admitted to Cal Poly Pomona for Fall 2004. At this point, it is possible for us to admit a small number of additional students to classes which begin in September 2004. Congratulations you are among this select group! Of course, this offer has minor conditions attached to it:

First, this admission is subject to your having successfully completed all eligibility requirements. We still need to conduct a careful review of your final transcripts and any other material we have already requested that complete your application. You must submit all required documents that we do not yet have, and these must be received in our office no later than **Monday, July 26, 2004**.

Second, we must receive your mandatory Enrollment Confirmation Deposit in our office no later than **Monday, July 19, 2004**. The attached letter explains this requirement more completely. We will use your Enrollment Confirmation Deposit to reserve a place for you for Fall 2004.

Third, you must be prepared to pay for and attend a mandatory orientation program during July or August. Information regarding orientation will be mailed to you separately.
