**OFFER OF ADMISSION IN 2010: MED  
(FULL-TIME PROGRAMME)**

I write to offer you admission to the programme leading to the degree of Master of Education as described on the enclosed Notice of Admission.

2. If you wish to accept this offer you should:

- a. complete the statement of acceptance on one copy of the Notice of Admission;
- b. pay an amount of HK\$42,350, being a deposit of HK\$42,000 and caution money of HK\$350 (please refer to the enclosed Student Debit Note for payment instructions); or if you are an overseas candidate, submit a Hong Kong dollar bankdraft drawn on a bank in Hong Kong or a crossed Hong Kong dollar cheque payable in Hong Kong for this amount (made payable to "The University of Hong Kong");
- c. return the completed Notice of Admission and a copy of the receipted debit note to the Programme Office (Room 219, Runme Shaw Building) by the date shown on the Notice of Admission. You will be invited to collect a Registration Folder containing further particulars from the Faculty Office at a later stage.

3. Please note that once you accept the offer, you are liable to pay the composition fee. The total composition fee in respect of this one-year full-time programme for the 2010-2011 intake is HK\$84,000\* and shall be payable in two installments. The deposit of \$42,000 shall be credited towards the first installment of the composition fee. Fees once paid are not refundable.

4. University Regulation G6 prohibits concurrent registration by a student for another postsecondary qualification either at this University or at another institution, unless approval of the Senate has been obtained in advance. A breach of this regulation may result in discontinuation of studies at this University. If you are in doubt about your own position with regard to this regulation, you should let me know as soon as possible.



The University may, at its discretion exercisable at any time, request you to produce original copies of certificates in support of all qualifications claimed by you in your application form, regardless of whether such certificates have been previously submitted to it. Should there be any discrepancy which the University deems to be material between your original certificates and the qualifications claimed in your application form, the University has the right to withdraw at any time the offer of admission and/or to treat any acceptance of the offer as null and void. The composition fee and other fees paid may be refunded, wholly or in part, at the discretion of the University.

6. If you do not wish to accept this offer you should complete the appropriate section on one copy of the Notice of Admission, and return it to me as soon as possible, so that the place may be offered to another candidate. **If you do not return a completed copy of the Notice of Admission and pay the deposit by the date shown, the offer of admission will automatically be withdrawn.** If you accept the offer and subsequently decide not to register for the programme you must notify me **in writing** before **June 30, 2010**.
